* S.A.S.E. – self-addressed stamped envelope for each event attending. You will receive a vendor map via mailed 2 weeks prior to each event you are registered for.

* Copy of your NYS Tax ID and/or NYS Health Permits.

* Check or money order in the full amount for each show.

* Minimum of three (3) photos of your handcrafted items.

***Your deposited check is confirmation for admittance to our shows.**



***After you are admitted to an event all vendors must obtain a Village of Lake George Annual Business Permit.** This permit is non-refundable. All Vendors are required to purchase a \$50.00 Village of Lake George Annual Business Permit. You will not be permitted to set up without this document.
